### **Around the globe: News stories on legal aid**

#### **Theme of the month**

The month's news has been much like the weather in London – cold, wet and miserable. Cuts and pressures to legal aid dominate the world – from Victoria in Australia where the lawyers are demonstrating outside the courts, through British Columbia which is experiencing a 'perfect storm' of greater calls on less money to the US where a variety of pressures are leading to severe cuts to civil legal provision. In this gloom, Scotland provides a rare flash of sunlight as it increases means-tested levels and the European Court of Human Rights decides that the right to legal assistance generally extends to the position during police interviews.

#### **Cases**

European Court of Human Rights endorses in *Salduz v Turkey* the general need for legal representation during police station interviews:

The Court found that in order for the right to a fair trial under Article 6 § 1 to remain sufficiently "practical and effective", access to a lawyer should be provided, as a rule, from the first police interview of a suspect, unless it could be demonstrated in the light of the particular circumstances of a given case that there had been compelling reasons to restrict this right. Even where compelling reasons might exceptionally justify denial of access to a lawyer, such restriction - whatever its justification - must not have unduly prejudiced the rights of the accused under Article 6. The rights of the defence would in principle be irretrievably prejudiced when incriminating statements made during a police interview without access to a lawyer were used as a basis for a conviction.
